## IMIA NI Advisory Panels – driving forward the future of Nursing Informatics

IMIA NI has four Advisory Panels whose members conduct periodic environmental scans and share knowledge and best practice around particular topic areas of nursing informatics: Education, Research, Practice and Governance (policy relating to nursing informatics cuts across all four panels). In this way, the Panels act collectively as a global observatory for Nursing Informatics, bringing together up-to-date knowledge and lived experience of members from around the world.

The current leadership of each of the panels is given below:

*IMIA NI Education Advisory Panel* – Max Topaz and Siobhán O’Connor

*IMIA NI Governance Advisory Panel* – William Goossen and Laura-Maria Peltonen

*IMIA NI Practice Advisory Panel* – Janette Gogler and Clair Lunt

*IMIA NI Research Advisory Panel* – Leanne Currie, Charlene Ronquillo and Aaron Conway

Nick Hardiker is the currently IMIA NI Vice-Chair with responsibility for Advisory Panels. Dawn Dowding will assume this responsibility in January 2025 as a member of the new IMIA Board.

The Advisory Panels replaced IMIA NI’s Working Groups in 2021, and together they seek to capture the evolving state-of-the-science for all four domains of Nursing Informatics. Since their inception, each of the Panels has provided summary information, advice and recommendations on a quarterly basis for consideration and possible action by the IMIA NI Board. In this way, the Panels provide a loud voice for members of our community. They also represent a precious resource for the IMIA NI Board in helping the organisation fulfil its role as the global advocate for Nursing Informatics.

Individual Panels have been instrumental in the organisation of online seminars and workshops, they have worked on white papers and potential policy/position statements for IMIA NI, and they have delivered conference presentations, such as at NI 2024, which was held in July in Manchester. The four Panels also came together last year to co-author a paper that was published in the IMIA Yearbook ‘[Nursing Informatics’ Contribution to One Health](#)<sup>1</sup>

Membership of the Panels is open to any individual with an interest in the topic area of the Panel, and with something to contribute, regardless of their professional background and their geographical location. Individuals can be a member of more than one Panel if their interests cover multiple areas. It is expected that IMIA NI member society representatives are a member of at least one Panel.

We hope to be able to showcase in future newsletters the work and aspirations of each of the Panels.
